




NOTICE OF PUBLIC MEETING

In order to ensure that every citizen desiring to speak before the Board has the opportunity to express his or her opinion, it is requested that members of the audience refrain from making comments or making any remarks or gestures that may interrupt, interfere with, or prevent the speaker from commenting on any present or future project.

NOTICE: to persons with disabilities: Reasonable efforts will be made to assist members of the public who are disabled and require special assistance or accommodations at the meeting. NOTICE: NRS 237: The Genoa Town Advisory Board has adopted a Standard Policy No. 7, which contains a motion regarding Business Impact Statements (BIS). When the Town Board approves its agenda, it also approves a motion, which includes ratification of staff action taken pursuant to NRS 237.030 et seq. With respect to items on the Board's agenda, including without limitation the conclusion that each rule, ordinance, or regulation that is on the Board's agenda, including without direct and significant economic burden on a business or that directly restricts the formation, operation, or expansion of a business, and that each rule, ordinance, or regulation that is on the Board's agenda for which a BIS has not been prepared does not impose a direct significant economic impact on a business or directly restrict the formation, operation, or expansion of a business.

NOTICE: Items on the agenda may be taken out of order; the Genoa Town Board may combine two or more agenda items for consideration, and the Genoa Town Board may remove an item from the agenda or delay discussion relating to an item on the agenda at any time.

5. **For possible action:** Discussion and update on the Centennial Genoa Candy Dance Lillian Virgin Finnegan Statue Project; with public comment prior to Board action. (10 minutes)
6. **For possible action:** Discussion to approve, approve with modifications, deny or defer the removal and recommended pruning of black locust trees along the north side of Mill Street. Competitive bids from Sierra Peaks Enterprises and Battle Born Tree Service put the estimated expense for all work, including labor, removal and cleanup at a cost not to exceed \$3000; with public comment prior to Board action. (10 minutes)
7. **For possible action:** Discussion to approve, approve with modification or deny the purchase and planting of a tree on the Campbell property of the Mormon Station State Historic Park and a tree in the Genoa Town Park as part of the 2017 Arbor Day Celebration. Estimated cost for both trees and planting not to exceed \$1000; with public comment prior to Board action. (10 minutes)
8. **For possible action:** Discussion on budget development for Fiscal Year 2017/2018 including, but not limited to:
 - a. review of tentative budget for FY2017-2018 with a review of revenue and expense estimates, and other matters properly related thereto;
 - b. review of capital projects for incorporation into the Douglas County Capital Improvement Projects (CIP) program budget; with public comment prior to Board action. (30 minutes)
9. **For possible action:** Discussion on update report for the 2017 Genoa Cowboy Festival; with public comment prior to Board action. (10 minutes)
